BREEDING SHED DATES: February 15, 201 – June 30, 2010

BOOKING HOURS: Mon – Fri: 7:30am - 4:30pm
Sat – Sun: 8:00am – 12:00pm

BREEDING TIMES: 8:30am and 2:00pm – *PLEASE BE ON TIME*

BREEDING SHED REQUIREMENTS

BARREN AND NOT BRED MARES: All barren mares and those not bred in 2009 are required to have a clean regular uterine culture within 30 days of breeding date. A clean culture certificate must accompany the mare to the breeding shed. A clean culture will be required for *ALL* return covers (not including doubles). The culture must be taken from the current heat period.

MAIDEN MARES: *ALL MAIDEN MARES MUST BE JUMPED BEFORE COMING TO THE BREEDING SHED.*
The clean culture requirements are the same as stated above for barren and not bred mares.

FOALING MARES: No culture is required for the first cover. A clean regular uterine culture is required for *ALL* return covers (not including doubles). The culture must be taken from the current heat period.

IMPORTED MAIDEN MARES: In addition to the normal requirements for maiden mares, all fillies of foreign origin (except Canada) which have not been qualified for cover during the previous breeding season are required to have two (2) sets of negative CEM cultures. One set of cultures must be obtained in early estrus; the second may be obtained during a period of 7 to 14 days before or after the culture in estrus. The first three (3) mares bred after an imported mare must be CF tested 25 to 40 days post-breeding.

IMPORTED FOALING AND BARREN MARES: Contact the State Veterinarian's Office in Frankfort regarding testing procedures and acquisition of a quarantine release. A copy of the *QUARANTINE RELEASE* must accompany the mare on her first trip to the breeding shed. The first three (3) mares bred after the imported mare will be required to have a CF test drawn 15 to 40 days post-breeding.

EVA POSITIVE MARES: Any mare which is EVA positive without proof of being sero-negative prior to vaccination must be identified as such when booking the mare and will be bred last in line on any given day.

Prior to May 1, 2010 we will not accept foal heat mare or book doubles to *READY'S IMAGE, SALUTE THE SARGE, SONGANDAPRAYER, or SUCCESSFUL APPEAL.*

*** *ALL* mares presented for breeding must be vaccinated for the Equine Herpes Virus type-1, within 7 to 90 days pre-breeding. A statement from a veterinarian attesting to vaccination must accompany the mare to the breeding shed. ***

*** Any mare presented for breeding without the proper identification (halter or neckstrap with mare's name on it) *WILL NOT BE BRED.* ***

*** Signed contract or Shareholder authorization and completed mare information sheets must be on file in office prior to breeding. *Breeding Shed forms are not required!* ***

*** Foal Heat and Doubles may be bumped on short notice for first trip mares. ***
